DRUG & ALCOHOL RECOGNITION-UPDATE (DAR)

COURSE DESCRIPTION:

Drug and Alcohol Recognition (DAR) is a 24-hour course designed to provide law enforcement personnel with the knowledge and skills to evaluate the effects of drugs and alcohol on an individual and to provide expert testimony on the evaluation. Topics include: legal codes, stimulants and depressants, investigative techniques and courtroom testimony. May be substituted for 11550 H & S.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and a grade submitted for their college transcripts. Only in-service peace officers shall receive POST credit.

<u>Important Note:</u> Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.

PREREQUISITES:

POST certified basic law enforcement academy or equivalent as determined by the Dean of Academy Instruction. NOTE: Approval of equivalent training is not a guarantee state regulatory or licensing agencies will also grant equivalency.

ENROLLMENT: *Mandatory College Enrollment Instructions / to obtain your college Student ID# (SID#):

- b) Please click on "Apply to American River College"
- **c)** If you are new to the OpenCCC website, you will need to create an account. Please write down your username and password as you may need it in the future. If you are a returning user, please log in with your username and password

- f) Include SID# in the Registration and Payment form.
