IMPACT WEAPONS INSTRUCTOR - UPDATE

COURSE DESCRIPTION:

Impact Weapons Instructor - Update is a 16-hour course designed to provide law enforcement agency impact weapons instructors with updated skills and knowledge in the use of force and the accompanying legal issues. Topics include: review of baton use, striking techniques, and liability updates.

Because this course is designed to provide practical hands on training in police tactics and weapon usage, participants in this course will engage in physically demanding classroom training exercises that include a risk of injury to the participants.

Upon completion of the course, all students will receive an ARC SRPSTC Certificate of Completion and a grade submitted for their college transcripts. Only in-service peace officers shall receive POST credit.

<u>Important Note:</u> Students are strongly encouraged to arrive on time in order to complete the registration process and avoid impeding instructional time. Late students who miss this process will not be allowed to attend the course.

ENROLLMENT LIMITATION:

Students must 1) Be free of felony convictions; 2) possess a valid California Driver's License; 3) undergo a fingerprint and criminal history check; 4) be a minimum of 18 years of age; 5) be a United States high school graduate; pass the GED, pass the California High School Proficiency Examination, or have attained a two-year or four-year degree from an accredited college or university; and 6) complete a medical suitability examination.

PREREQUISITES:

Successful completion of basic Law Enforcement Academy and Impact Weapons Instructor course.

Prerequisites will be checked prior to the first day of training.

MATERIALS NEEDED:

Gym clothes, agency issued Impact Weapon, work out gloves, or boxing hand wrap or tape for fingers, notebook, and

pen.

ENROLLMENT:

*Mandatory College Enrollment Instructions / to obtain your college Student ID# (SID#):

- a) Please click on the following link: http://www.losrios.edu/lrc/lrc app.php
- b) Please click on "Apply to American River College"
- c) If you are new to the OpenCCC website, you will need to create an account. Please write down your username and password as you may need it in the future. If you are a returning user, please log in with your username and password
- d) Once you're done creating an account or signing in, click on "start a new application"
- e) This will take you to the application you need to complete in order to obtain your Student ID#
- f) Include SID# in the Registration and Payment form.
